



Balaji Medical College's summer camp on health science

Chennai, May 31: The first summer camp focused on medicine and health science for school students was held at Sri Balaji Medical College and Hospital in Chromepet, Chennai, from May 29 to 31, 2025. Fully funded by the Tamil Nadu State Council for Science and Technology (TNSCST), the three-day camp saw the participation of 25

students from various schools. On the first day, students explored medical laboratories related to biochemistry, microbiology, and pathology. On the second day, students received hands-on training in Cardiorespiratory Resuscitation (CPR), which is vital for emergency care. On the third day, students

visited the departments of orthopedics and human anatomy, where they learned new information about the human skeletal system and the functions of bones.

The event was organized under the leadership of Executive Director Mr. Ilamaran and Dean Dr. P. Sasikumar. The chief guest was Dr. C. Arulvasu, Controller of Examinations at the University of Madras. At the valedictory function, Mrs. A. Jayalakshmi, IPS, Superintendent of the State Human Rights Commission, and Mr. C. Kandhasamy, retired District Educational Officer and District NSS Officer, were the special guests.

Key members of the institution, including Dr. S. Veerabagu (Advisor), Dr. Manoharan (Medical Supervisor), Dr. Renuka Devi (Vice Principal), and Camp Coordinator Dr. Rathinam Raja, extended a warm welcome and congratulated the students. The students also received guidance regarding the MBBS entrance examination (NEET).
